#### TERMS AND CONDITIONS OF USING THE ONLINE PAYMENT GATEWAY

- B. You have engaged with RCFL as a client of its hire purchase services, credit finance services and/or leasing services and/or you have a payment due to RCFL.

### Terms of Use between you and RCFL

As a client using this online payment gateway (hereinafter 'Client' or 'you'), we request you to please read these terms carefully before making an online payment.

By accepting to access Online Payment Services" through the use of your National ID (if you are an individual client) or your Business Registration Number (if you are a corporate entity) and your password, you bind yourself formally and irrevocably to the Terms herein contained.

If you do not agree with these terms and conditions of this policy, please do not process further to use this Site or the Online Payment Services.

The Site is accessible to the Clients for the purpose of paying their monthly instalments or any other payments due to RCFL. (hereinafter referred to as the "Online Payment Services")

RCFL places the Online Payment Services at your disposal on a 24/7 basis except when instructed otherwise on the Site. ### Representations and Warranties

## Responsibility for Log-in Data

The Client acknowledges that for each use of the Online Payment Services, the Client must each time register for the services on the Site by using their National Identity Card number or Business Registration Number, as applicable and mobile number or email address, as applicable. The mobile number and email address shall be pre-registered with RCFL. The Client shall receive a one-time-password. Each access to the Site to use the Online Payment Services, will be via a different one-time password.

## Accuracy of Information

You undertake to provide your contact data and other details as requested by RCFL for the completion of the confirmation process for your access to use the Online Payment Services. You warrant the accuracy and genuineness of your information uploaded on the Site.

If you provide any information that is untrue, inaccurate not current or incomplete or RCFL has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, RCFL has the right to indefinitely suspend or delete your and refuse to provide you with access the Site.

You will be solely responsible for the security and confidentiality of your password, which you will not reveal to any third party or any representative or agent of RCFL. RCFL expressly disclaims all liabilities that may arise as a consequence of any unauthorised use of your password. You shall notify RCFL in case of any known or suspected unauthorised use(s) of your account, or any known or suspected breach of security, including loss, theft, or unauthorized disclosure of your password.

The information and data that you provide during this online transaction will only be used for the purpose of recording your payment and the your prepaid/credit/debit card/account details will be processed and stored by the Payment Gateway Service provider. RCFL shall not store any information with respect to your credit/debit card and any of your bank account details.

RCFL shall incur no liability whatsoever with respect to the performance and execution by the Site, of any of such instruction, data and/or message thereof.

### **Payment Process**

Any Payment Amount can be made:

- by selecting instalment or payments due and paying them in full (this pays only the selected items);
- by entering the total amount to pay in the text box and making the payment.

While processing your payment, you may be required to provide your prepaid, credit or debit card details and other personal data to the Approved Payment Gateway Service Providers. In this regard, you agree to provide correct and accurate prepaid/credit/ debit card details to the Approved Payment Gateway Service Providers for availing the Online Payment Services on the Site. If your mode of payment is via my.t money, you shall be directed to a QR code. You will have to open your my.t money app, go to 'Scan QR code', and make a quick scan of the our QR code. You will be directed to enter the total amount you have selected to pay and your my.t money PIN to validate the payment.

Payment(s) effected are non-refundable except in very specific circumstances; in which case the complaint has to be lodged with RCFL.

Multiple payment transactions are allowed. If payments are made after 9 pm, the payment shall be processed on the next business day. Surcharge or late payment fees shall be applied, where applicable, in the event the Client has made a payment after the 9pm cut-off time of the due date of payment. It is your responsibility to verify, that payment corresponds to what should have been paid and that payment has well been done. All dates and times on the Online Payment Services refer to dates and times prevailing in Mauritius.

You shall not use the prepaid/credit/ debit card or payment account which is not lawfully owned by you. The information provided by you will not be utilized or shared with any third party unless required in relation to fraud verifications or by law, regulation or court order. You will be solely responsible for the security and confidentiality of your credit/ debit card details. RCFL expressly disclaims all liabilities that may arise as a consequence of any unauthorized use of your payment details.

All payments will be processed on the basis of the information that you provide. RCFL does not accept any liability if you make a mistake while filling in the details or for any reason whatsoever.

Once the payment has been confirmed online, you will be given a transaction reference number and a transaction payment confirmation. You shall be able to view all your online payment transactions. Please note the transaction number and quote it for any queries regarding your payment.

Your payment instructions on the Online Payment Services are irrevocable and unconditional and cannot be altered, modified, amended, restrained or extended.

# **Privacy Policy**

We process your personal data in accordance with the Data Protection Act 2017, which is itself aligned with the General Data Protection Regulation. We encourage you to consult our <u>Data Protection Notice</u>, where the details of such processing are set out. Except as required by law, RCFL is committed to protect your confidential data; ("Your information"), as mentioned in the present paragraph, includes all information concerning you, provided by yourself or by third parties.

By using this site, you agree that RCFL will have no liability for disclosure of your information due to errors in transmission or unauthorized acts of third parties.
